Passengers can be jolted, jarred, thrown to and fro, and other wise be shaken about during rides, or could possibly be ejected from the boat. In the 25-plus years that Beamers Hells Canyon Tours has been doing business, no death, nor drowning, nor ejection has ever occurred.
